We sold our land in panic. But now, we are determined to get it back," he said. When contacted, the sub-registrar in Karjat, D P Pandit, said there were 17 land transactions made by around 50-60 farmers, some jointly with family members, during that period. "A majority of the transactions were done in 2011 and in the two subsequent years," he said. According to officials at the sub-registrar for fice, the land was purchased through "power of attorney" on behalf of Modi for his company.

"Modi set up a solar plant on 60 acres of that land without converting the agriculture land into non-agriculture land. We imposed a fine of account Rs 10 lask on the company," said Acronding Engineer at the Ahmednagar office of state-owned MSEDCL.
